After the allocations, purchase agreements must be signed within five working days at the latest. The project notary Schut|Van Os Notarissen has scheduled a time to discuss and sign the deed of sale.

If your preferred home is not available, you may be placed on a standby list if desired. 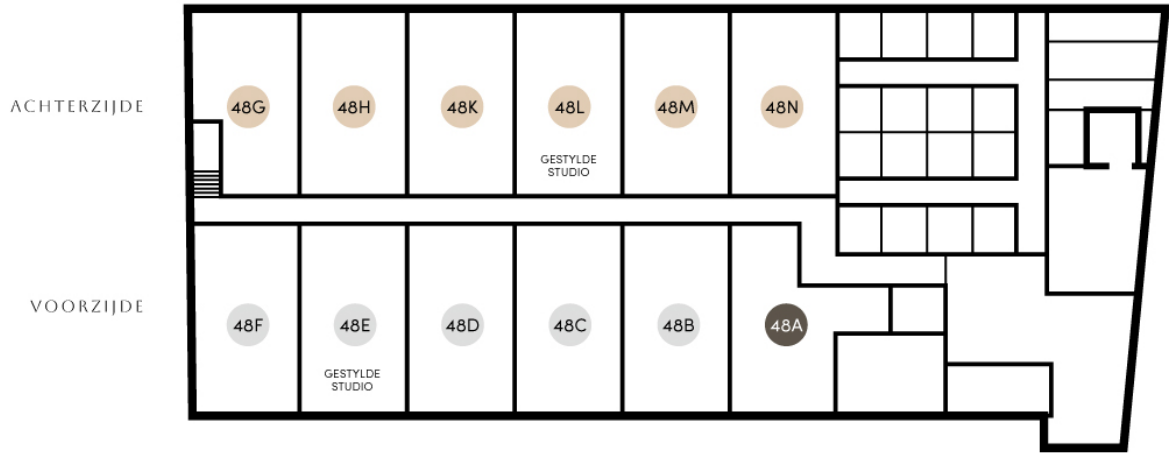

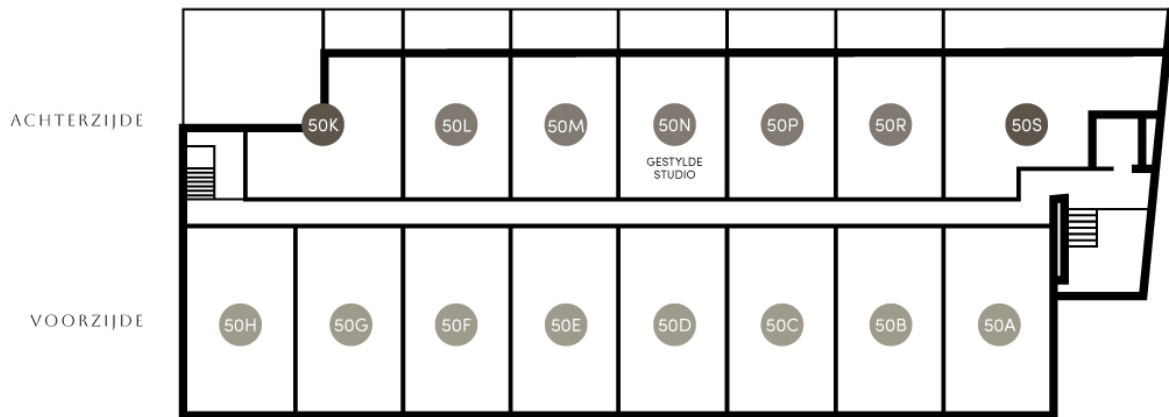
